**21.17.53.2      SCOPE:** This rule shall apply to all persons certified to use restricted-use pesticides --  
commercial applicators, private applicators, public applicators and non-commercial applicators.

**21.17.53.4      DURATION:** Permanent.

**21.17.53.6      OBJECTIVE:** The objective of Part 53 of Chapter 17 is to establish the mechanism for granting  
continuing education units for the recertification of private, commercial, non-commercial and public pesticide  
applicators.

**21.17.53.7      DEFINITIONS:**

**A.      "Continuing education unit" (CEU)** means a credit granted for the attendance and successful  
completion of an approved training or educational workshop or seminar held for the certification or recertification of  
private, commercial, non-commercial or public pesticide applicators, and pest management consultants with the 7D  
category on their license.

**B.      "Certification period" means:**  
**(1)**      the one year period following the year of issuance of a commercial, public ~~[or]~~, non-  
commercial applicator, or pest management consultant license;  
**(2)**      the five year period following the year of issuance of a private applicator license.

**C.      "Recertification training" means** workshops, seminars, classes or similar educational forums  
with instruction on pesticide use approved by the New Mexico department of agriculture (NMDA)~~[-]~~ ;

**D.      "Core education" means** training in basic safety, principles of integrated pest management,  
information on best management practices, and other similar topics as approved by NMDA.

**21.17.53.8      RECERTIFICATION:** The requirements contained in this section are the minimum required for  
recertification.

**A.      All commercial~~[-, public and]~~ applicators, non-commercial applicators, public applicators, public  
pest management consultants, and pest management consultants (with a 7D Category) shall be recertified annually  
following the initial issuance of their license. Applicators and consultants shall recertify by one of the following  
methods:**

**(1)**      Complete the original certification requirements by passing each required examination  
with a score of 70% or above: or

**(2)**      Participate in approved continuing education courses to accumulate a minimum of four  
CEUs during the license year, to consist of one CEU in laws and rules, one CEU in Core education topics, and two  
CEUs in each category covered by their certification, other than Categories 7D, 9, and 10. Applicators certified in  
category 7D must comply with requirements listed in 21.17.51.8. Applicators certified in Categories 9 or ~~[and/or]~~ 10

will be recertified in those categories provided they earn the required CEUs in the other categories covered by their certifications.

(3) Consultants, public or private, with a 7D category – participate in approved continuing education courses to accumulate a minimum of four CEUs during the license year in the category 7D as specified in 21.17.51.8.

B. [A minimum of four CEUs shall be required for the annual recertification of commercial, public or non-commercial applicators.] All operators shall be recertified annually following the issuance of their license. Operators shall recertify by one of the following methods:

(1) Complete the original certification requirements by passing each required examination with a score of 70% or above; or

(2) Participate in approved continuing education courses to accumulate a minimum of three CEUs during the license year, to consist of one CEU in laws and rules and two CEUs in Core education topics and/or category groups. Termite operators must participate in a minimum of four CEUs in the wood destroying pests category to maintain that certification as listed in 21.17.51.8.

C. [Private] All private applicators shall be recertified every five years following the [initial] issuance of their [certification] license. Private applicators shall recertify by one of the following methods:

(1) Complete the original certification requirements by passing each required examination with a score of 70% or above; or

(2) Participate in approved certification education courses to accumulate a minimum of five CEUs during the license period of five years, to consist of two CEUs in laws and rules and three CEUs in Core education topics or category groups related to agricultural pest control.

D. [A minimum of five CEUs shall be required for recertification of private applicators.] Maximum CEUs: Applicators who earn 10 or more CEUs including one in laws and rules, one in Core education, and eight or more in certification categories will be eligible for certification in all their categories except 7D (Termite and other wood-destroying pests), 11A (Soil fumigation), 11B (Structural fumigation), and 12B (Predator control).

[E. No more than one CEU per certification period shall be awarded for attendance at product sales meetings.

F. A maximum of one CEU shall be awarded per certification period for approved in-house training programs.

G. The number of hours for recertification contained in this section are the minimum required for general recertification. Recertification in specific categories may require more than these minimums and may be specified in separate regulations relating to specific license categories.]

**21.17.53.9 APPROVAL OF RECERTIFICATION TRAINING:** NMDA shall have final and sole [approval of any program seeking CEUs and shall have complete] authority in the awarding of CEUs for any approved educational program. CEUs shall be awarded only for core educational topics including safe, effective use of pesticides and the state and federal laws and rules governing pesticide use.

A. Persons seeking approval of educational programs for CEUs shall submit to NMDA for review, at least 15 days prior to the beginning date for the program, information on the program including a copy of the program complete with topics, copies of any handouts or other materials to be used in the program, detailed description of each topic for which CEUs are sought, the length of the presentation per topic, names and qualifications of speakers, and other information required by the director.

B. Persons sponsoring an approved educational program shall allow at least two NMDA employees to attend and monitor the program without payment of any registration fee.

C. Persons sponsoring recertification training shall complete and return to NMDA a copy of the meeting attendance roster no later than 10 days from the last day of the program.

D. One CEU shall be awarded for each hour of approved instruction or training.

E. One CEU shall be the smallest unit awarded.

F. Educational programs that fail to cover the topics submitted for recertification credit shall be subject to revocation of any awarded CEUs.

**21.17.53.10 [GROUPING OF LICENSE CATEGORIES] CATEGORY GROUPS FOR RECERTIFICATION:** [Training] CEUs for recertification of categories shall be grouped [in one of the following

categories]. NMDA shall make the final determination, based on sponsors' descriptions of recertification training, as to what [categories] category or category group any approved [recertification] educational program shall apply.

- A. ~~[pesticide use and safety;]~~ Category groups include:  
(1) Agricultural CEU group: Categories 1A, 1B, 1C, 2, 6B, PRAP  
(2) Ornamental and turf CEU group: Categories 3A, 3B, 2, 6B  
(3) Structural CEU group: Categories 7A, 7B
- B. ~~[wood destroying organisms;]~~ CEUs for recertification of the following categories shall not be grouped:

- (1) 1D – Aerial application,  
(2) 4 – Seed treatment,  
(3) 5 – Aquatic pests and weeds,  
(4) 6A – Industrial wood preservation,  
(5) 7D – Termite and other wood-destroying pests,  
(6) 8 – Public health pests,  
(7) 11A – Soil fumigation,  
(8) 11B – Structural fumigation,  
(9) 11C – Rodent burrow fumigation,  
(10) 12A – Wildlife pests,  
(11) 12B – Predator control, and  
(12) 13 – Other limited use.

C. ~~[private applicator.]~~ Applicators may request a variance from the director in the event that limited training was available for a specific category during the license year. The request shall be made in writing within 30 days after the license expiration date.

#### **21.17.53.11 AWARDING CONTINUING EDUCATION UNITS:**

A. One CEU shall be awarded for each hour of approved instruction or training, except for the following.

~~(1) [A half CEU shall be the maximum awarded for any approved product sales meeting.]~~  
One CEU shall be the maximum awarded for any approved product sales meeting.

~~(2) One CEU shall be the maximum awarded for any approved in-house training program.~~

B. One hour of instruction or training shall be equal to at least 45 minutes of contact time. ~~[One half hour of instruction or training shall be equal to at least 20 minutes of contact time.]~~

C. ~~[A half]~~ One CEU shall be the smallest unit awarded.

D. CEUs shall be awarded only for topics relating to the safe effective use of pesticides and the laws and rules governing pesticide use.

E. Persons seeking approval of programs for CEUs shall submit, at least 15 days prior to the beginning date for the meeting, a copy of the program ~~[complete with]~~ including: 1) topics; 2) short description of each topic; 3) length of presentation per topic; and 4) speakers.

F. Persons seeking approval of programs for CEUs shall allow at least two NMDA employees to attend any training program for purposes of monitoring the training without payment of any registration fee.

G. Persons awarded approval for CEUs for an approved program shall complete and return to NMDA a copy of the meeting attendance roster.

H. Attendance rosters must be ~~[post-marked]~~ submitted to NMDA no later than 10 days from the last day of the training workshop or seminar.

~~[I. It shall be the responsibility of the applicator to return all CEU cards to NMDA.]~~

~~[J. For programs where CEU cards are issued, NMDA shall credit CEUs for individual applicators based solely on returned CEU cards.]~~

~~K-I.~~ NMDA may accept CEUs from state or federal agencies on submittal of acceptable documentation.
