INFORMATION FOR APPLICANTS

A separate license is required for each location which purchases in-shell pecans within New Mexico.

Record Keeping Requirements:

Information obtained by each buyer of in-shell pecans from the seller shall include:

1. Location and date of the purchase;
2. Name, telephone number, and address of the seller;
3. Street address or physical location of the tree or the farm from where the in-shell pecans originated;
4. Personal identification number obtained from either a drivers' license, military identification card, or passport issued by the United States;
5. License plate number, make and model of the seller's motor vehicle;
6. Total weight of the in-shell nuts purchased.
 - Ensure record of the purchase of in-shell pecans are available for inspection by the department or a peace officer within forty-eight hours of a transaction;
 - Retain records of purchase of in-shell pecans for a minimum of two years.
